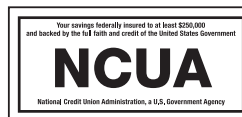

**A:** Have a total share balance of \$300.00 or greater; **OR B:** Are using one or more of the following services: Checking, IRA, HSA, Loan(s), HCU Visa, or Certificate(s). Members not meeting the above criteria will be subject to a check cashing fee of approved checks at the rate of \$3.00 plus \$1.00 per hundred.
