### **Patriot Act Notice**

The US Patriot Act requires financial institutions to obtain information from an individual or legal entity to help establish identity. Your cooperation is needed when you open a new account or request a loan. You may be asked more questions to establish and confirm your identity. It may also be required for you to provide one or more forms of identification.

### **IRA Withholding Notice**

Payments from your IRA are subject to federal income tax withholding, unless you elect no withholding.

You may change your withholding election at any time prior to your receipt of a payment. To change your withholding election, complete the appropriate form provided by HCU.

Withholding from IRA payments, when combined with other withholdings, may relieve you from payment of estimated income taxes. However, your withholding election does not affect the amount of income tax you pay.

You may incur penalties under the estimated tax rules if your withholding and estimated payments are insufficient.

### Important Changes to Heartland's Membership Agreement

Effective March 1, 2024 the following changes will be made to the Heartland Credit Union membership agreement. These changes are in response to a new State statute that preserves the privacy of and protects both the member and the Credit Union if it is necessary to remove someone from membership.

We may terminate your membership in Heartland Credit Union in one of two ways. The first way may be initiated by Credit Union employees designated by the Board of Directors or CEO, for the reasons listed below. The second way to terminate your membership is by a two-thirds majority vote of the members present at a regular meeting of Heartland Credit Union.

Cause is defined as follows: (A) a substantial or repeated violation of Heartland Credit Union's membership agreement; (B) a substantial or repeated disruption to the Credit Union's operations, including dangerous or abusive behavior toward HCU property or employees; or (C) fraud, attempted fraud, or other illegal conduct that a member has been convicted of in relation to Heartland Credit Union, including in connection with our employees conducting business on behalf of us.

An expelled member shall be promptly informed of the reason for their expulsion and have the right to appeal their expulsion by making a written request to the Board of Directors within 30 days of the expulsion. Any member that has been expelled shall be reported in writing to the Board of Directors at the next regularly scheduled meeting.
